What it does:

- A June 2025 Housing Snapshot reports a yearover-year increase in total mortgage originations (+12.2%), with rising inventory and stronger listings. This signals potentially higher demand for home inspection services, especially for firms prepared to scale efficiently
- **Bureau of Labor Statistics projections** show a 10% workforce growth for home inspectors by 2026, meaning more competition—but also more overall demand

San Francisco Home Inspection Scandal — A **Cautionary Tale**

In February 2025, the San Francisco Chronicle published the case of Andreu Osika and Aleksandra Kenar, who bought a newly renovated home in Bernal Heights. After they moved in, the couple discovered severe plumbing and structural issues—particularly a disintegrating sewer line and foundation defects—that cost them at least \$650,000 in repairs and emotional distress.

The twist? These problems stemmed not from normal wear or homeowner oversight, but from corrupt city officials involved in the inspection process:

- Bernard Curran, a DBI (Department of Building Inspection) agent, accepted bribes and approved faulty renovation work.
- Rodrigo Santos, a structural engineer, admitted to bribing Curran to bypass safety checks.
- Both were convicted of fraud. As a result, over 130 homeowners across San Francisco faced mandatory repairs and fines—often without financial protection or legal recourse San Francisco Chronicle.

NEW ENGLAND SPOTLIGHT

T New Hampshire — SB188 ("Speeding" Development Act") — Effective July 15, 2025

• This law authorizes licensed engineers,

- architects, and building-code administrators to serve as private providers for building-code inspections and plan reviews, rather than relying solely on municipal inspector.
- It allows property owners or developers to choose third-party compliance verification, which may include structural, electrical, or structural safety reviews typically handled by local agencies.
- Draft plans and completed inspections by these private third-party providers are subject to random audits by local authorities to ensure code compliance.

Recall Center:

Trane / American Standard Gas-Electric **Packaged Units**

- Recall Date: July 3, 2025
- Issue: Faulty fuel gas valve may open unexpectedly, causing gas leaks and fire risk.
- Units Affected: Approximately 4,790 packaged units sold under Trane and American Standard brands.
- Remedy: Owners must stop using heating mode and contact their installer for a free ignition board replacement. One gas leak reported, no injuries so far.

Rinnai i-Series Plus Gas Boilers

- Recall Date: June 5, 2025
- Issue: Incorrect screws can prevent the boiler door from sealing properly, risking CO exposure.
- Units Affected: About 2,030 units in the U.S. and 249 in Canada.
- Remedy: Free repair by certified techs; users should keep CO alarms active in the meantime. **U.S. Consumer Product Safety Commission**

HTP ELU Elite Ultra Gas Boilers (NTI)

- Recall Date: June 5, 2025
- Issue: Boiler door seal may fail due to incorrect parts, risking fire and CO poisoning.
- Units Affected: 96 units (plus 9 sold in Canada).
- Remedy: Certified technicians will provide free repair; consumers advised to maintain CO alarms while awaiting service. The Sun+15U.S. Consumer Product Safety

Current state of home inspections?

 The home inspection industry in Connecticut remains steady, with increasing attention on buyer protections and evolving expectations for inspection depth. While no major legislation has passed yet, a proposed bill earlier this year (HB 6356) sought to establish a non-waivable right to a home inspection—mirroring Massachusetts' new policy. Although the bill didn't advance, its introduction signals potential future regulation. At the same time, more inspectors are adopting technologies like drones, Al-powered reporting tools, and thermal imaging to stay competitive and deliver higher-value services.
