New Jersey Enacts Law to Safeguard Structural Integrity of Residential Buildings

In response to concerns about building safety, New Jersey has passed legislation mandating regular inspections of primary load-bearing systems in residential structures, including condominiums and cooperatives. The law also requires capital reserve studies to ensure adequate funding for necessary repairs, aiming to prevent structural failures and enhance resident safety.

NEW ENGLAND SPOTLIGHT

Rhode Island Restricts Home Inspectors from Conducting Electrical Inspections

As of January 30, 2025, Rhode Island has enacted a law prohibiting home inspectors from performing most types of electrical inspections, including opening electrical panels. This change mandates that only licensed electricians can conduct these evaluations, potentially impacting the scope of standard home inspections and requiring buyers to coordinate additional specialized assessments during the inspection period.

GoveeLife and Govee Smart Electric Space **Heaters Recall**

Issue: GoveeLife and Govee have recalled approximately 512,500 smart electric space heaters in the U.S. due to fire and burn hazards. The heaters can overheat, and testing determined they do not comply with the voluntary industry safety standard UL 1278. The recall includes models H7130 (including H7130101), H7131, H7132, H7133, H7134, and H7135. There have been 113 reports of overheating, including seven fires and one minor burn injury. Consumers should immediately stop using the heaters and contact Govee for a refund.

Rheem Performance Platinum <u>Electric</u> Water Heaters (2016 Recall)

- Hazard: The control panel on certain Rheem Performance Platinum electric water heaters can overheat, posing fire and burn hazards. U.S. Consumer Product Safety Commission+4U.S. Consumer Product Safety Commission+4Rheem+4
- Units Affected: Approximately 54,000 units in 40, 50, and 80-gallon capacities sold exclusively at The Home Depot between January 2014 and April 2016.Rheem+4Rheem+4Rheem+4

PARIS: Precision Application Robot for Inaccessible Spaces

Developed to enhance safety and efficiency, PARIS is a teleoperated mobile robot designed for inspecting and performing tasks in confined spaces like attics and crawlspaces. Equipped with mapping and navigation capabilities, it can identify under-insulated areas and apply air-sealing treatments, reducing the need for inspectors to enter potentially hazardous environments.
