m Connecticut Bill for Property **Damage Grant Eligibility**

What it does:

- As of June 16, 2025, a new Connecticut law requires that licensed home inspectors must evaluate **property damage** before homeowners can receive state grants for repairs.
- This applies to homeowners seeking financial assistance for repairs—especially those recovering from disasters or other damage.

"The Case of the Missing Attic"

From the Field: A Real Story from a Cornerstone Home Inspector

Last month, one of our inspectors showed up to a routine inspection at a cozy Cape Cod-style home built in the 1940s. Everything looked typical at first wood siding, original hardwood floors, even the oldfashioned phone nook in the hallway. But when it came time to inspect the attic, things got interesting.

There was no attic access.

Not in the hallway, not in the closet, not even in the garage. The inspector triple-checked the layout, shined a flashlight around every ceiling corner, even called the listing agent—nothing. The seller, a kind elderly woman, swore there was never an attic. "Just roof up there," she insisted.

But from the outside, the inspector could see ventilation grilles—and enough roof pitch to hide a small room. A thermal camera confirmed it: there was an attic, and it was at least partially finished. It turned out that years earlier, the access panel had been drywalled over during a ceiling renovation completely sealed and painted as if it never existed.

The buyer, an investor, was grateful the inspector caught it. The hidden attic space became a valuable bargaining chip—and is now being remodeled into a bonus room.

Moral of the story: Just because you can't see it doesn't mean it isn't there. A good inspector looks past what's obvious.

Other Home Inspection—Related **Legislation: Connecticut**

These are currently in the pipeline or still under review:

- 1. House Bill 7078 (introduced April 2, 2025)
 - Would require sellers to provide a comprehensive Residential Condition Report, covering structural integrity (including issues like pyrrhotite) and building documentation. This bill encourages—but doesn't *mandate* pre-purchase inspections
- 2. House Bill 6356 (introduced January 23, 2025)
 - Proposes a non-waivable right for homebuyers to obtain a home inspection—meaning sellers couldn't condition a sale on buyers waiving the inspection
- 3. House Bill 7029 (introduced February 21, 2025)
 - Aims to certify independent inspectors and firms to perform inspections under the State **Building Code**

To date, none of these three bills (7078, 6356, 7029) have passed into law—they remain in draft or committee stages.

Triangle Tube: Prestige & Aerco Esteem **Condensing Gas Boilers**

- Recall Date: February 27, 2025
- Units Affected: ~60,000 in the U.S. plus 7,500 in Canada
- Models: Prestige Solo, Prestige Excellence, and Aerco Esteem
- Hazard: Units may release carbon monoxide due to delayed ignitions or component damage. There have been two reported deaths, and 25 other CO leak reports cpsc.gov+8cpsc.gov+8cpsc.gov+8. Remedy: Free inspection and repair by Triangle
