UK's Claim.co.uk Uses Al for Early **Detection in Home Maintenance**

In the UK, Claim.co.uk is leveraging artificial intelligence to help homeowners detect structural problems early—evaluating property images in as little as 1.5 seconds with 95% accuracy. While this is outside the U.S., it reflects a broader technological shift toward preemptive inspection and diagnostics that could influence global industry standards.

NEW ENGLAND SPOTLIGHT

Connecticut: Highest Inspection Prices in the Nation

- In 2023, the average home inspection cost in the Northeast was \$547. Connecticut topped the charts with the highest average quote at \$743.
- As of August 2024, Connecticut still held the distinction of the most expensive inspections, averaging around \$771, compared to Maine's \$654 and Massachusetts at \$593

Recall Center

Schneider Electric / Square D QO Plug-On-Neutral Electrical Panels

- In June 2022, about 1.4 million QO series electrical panels were recalled due to a potential loose neutral connection that could lead to overheating, thermal burn, or fire hazards.
- Affected panels were manufactured between February 1, 2020, and January 12, 2022. Inspectors should advise clients to have these panels evaluated—unit interiors must be checked (preferably by a licensed electrician).

Trane Voluntary Recall – Ground Wire **Overheating**

- Issue: A voluntary recall was issued around July 2025 for select Trane and American Standard packaged units. A ground wire in the control box can overheat, creating fire risk.
- Units Affected: About 23,000 units from 2019 to 2021.
- **Action**: Inspectors should advise homeowners or property managers to check serial numbers and contact Trane for a free inspection and repair.

Midea U and U+ Window Air Conditioners

- Issue: These models (sold under brands like Midea, Frigidaire, Danby, Insignia, and more) have condensate drainage issues. Poor drainage can lead to mold growth, posing respiratory health risks.
- Scope: About 1.7 million units recalled in June 2025.
- Action: Inspectors should flag these window AC units and recommend clients pursue repair or full refund options from the manufacturer.

- Safety: Detects small leaks of natural gas (methane), propane, or other combustible gases that aren't always obvious by smell.
